Agreement of regulations for
TEXAS Scroll Saw Picnic
June 11-12, 2010

1. **Vendors should check-in through the front door of the Civic Center beginning at 7:00 am on Friday June 11, 2010 before unloading any products.**
 2. **Vendors may begin set-up at 7:30 a.m. on Friday June 11, 2010 and must be completed by 1:00 p.m.**
 3. **Tear down / removal must be completed by 8:00 p.m. on Saturday June 12. There will be volunteers available to help you remove your booth materials from the building.**
 4. **Vendor displays will be attended and remain open to the public from 1:00 p.m. to 6:00 p.m. on Friday June 11 and from 9:00 am to 4:00 pm on Saturday June 12. No early tear down or packing of items will be permitted during show hours.**
 5. **Installation and removal of exhibits is at the expense of the vendors. At event closing, all exhibits, goods and materials must be removed.**
 6. **Use of nails, screws, tacks, tapes or other attachment to walls, floors, or dividers is prohibited and all costs incurred in repair of damages of such action will be the responsibility of the vendor.**
 7. **It is the responsibility of the vendor to remove valuables/ precious property when the booth is unattended.**
 8. **Vendors must abide by all fire regulations and/or decisions of the local fire department. All booth materials must be in accordance with local fire regulations.**
 9. **Vendors are not to have alcoholic beverages in the civic center.**
 10. **Vendors are responsible for keeping their area clean during event hours, including cleanup at the end of the day. Trash must be placed in designated receptacles.**
 11. **Displays should be neat and clean with tables covered. Wood vendors are not required to cover tables.**
 12. **Vendors must comply with Texas laws regarding collection and payment of sales tax.**
